The Woodridge Park District is a local government agency located in the southeast corner of DuPage County and northeastern Will County. The District provides park and recreation services for a resident population of approximately 35,531 and is governed by an elected five person Board of Commissioners. The operation budget of the district varies year to year; the approved 2010-11 operation budget was \$14,367,778.00.

The District maintains four offices: Community Center, 2600 Center Drive, Maintenance Building, 8325 S. Janes Avenue, Cypress Cove Family Aquatic Park, 8301 S. Janes Avenue, Village Greens Golf Course, 1575 W. 75th Street. There are twenty-eight full time employees and approximately 400 part time employees.
