

ORDINANCE NO. 11-15

**ESTABLISHING FEES AND CHARGES FOR USE OF
DISTRICT FACILITIES, SERVICES, AND PROGRAMS
WOODRIDGE PARK DISTRICT**

WHEREAS, the Woodridge Park District (the "District") is authorized to establish fees for the use of certain facilities and recreation programs of the District and to derive revenue from non-residents from their operations; and

WHEREAS, the District uses general tax revenues to provide certain basic programs, services and facilities of general availability and use to all District residents; and

WHEREAS, general tax revenues provide approximately 45% percent of the District revenues received annually and are insufficient to accommodate the operation, maintenance and administrative costs of providing District programs, services, facilities and special use areas; and

WHEREAS, the District assesses fees and charges to the users of District programs, services, revenue facilities, special use and enterprise areas that provide benefits to a limited and identifiable group of users, which are in addition to those enjoyed by the general public where the costs of providing the services can be determined; and

NOW, THEREFORE, BE IT ORDAINED, by the Board of the Woodridge Park District,
THAT;

SECTION 1: Recitals. The recitals set forth above are incorporated as a part of the Ordinance by this reference.

SECTION 2: Establishment of Fees and Charges for Designated Picnic Areas, Athletic Fields, Athletic Courts and Community Center Rooms. The schedule of fees and charges for the use of certain District facilities and services are hereby established:

SECTION 3: Establishment of Fees and Charges for Aquatic and Golf Course Facilities (Revenue Producing Facilities Established within an Enterprise or Agency Fund). The Executive Director shall on an annual fiscal year basis recommend fees and charges for the aquatic and golf course facilities for Board review and approval in accordance with the annual budget review and approval process for each respective facility.

SECTION 4: Authority to Establish Fees and Charges. The District Executive Director is hereby authorized to establish fees and charges, in a manner consistent with the District’s adopted Recreation Programming Revenue Policy, for the use of District recreation programs.

SECTION 5: Authority to Waive or Reduce Fees. The Executive Director or designate, may waive or reduce fees for community center room rentals if such a waiver or reduction is deemed in the best interest of the District, for a specific public benefit or other governmental uses as may be available and within normal hours of operation. Use of District facilities for commercial, private, political or personal purposes, gain or benefit without an approved agreement with the District or paying established fees, is not permitted.

SECTION 6: Scholarship and Inclusion Programs. The Executive Director or designate may offer partial fee scholarships for qualified low-income individuals for selected programs according to guidelines approved by the Woodridge Park Board of Commissioners.

SECTION 7: Availability of Annual Fee Ordinance. The Executive Director is hereby authorized and directed to make available to the public the fees and charges established in this Ordinance and such other fees and charges established from time to time pursuant to this Ordinance.

SECTION 8: Repeal of Prior Fees and Charges. All ordinances, resolutions or other actions of the District establishing fees and charges for District programs, services and facilities are hereby repealed.


SECTION 9: Effective Date. This Ordinance shall be in full force and effect on and after January 1, 2012, following its passage and approval in the manner provided by law.
