Comments received prior to 5:30 p.m. local time on April 21, 2020 will be read aloud by staff during the "Public Participation" section of the meeting agenda not-to-exceed 5 minutes for each comment. Comments received between 5:30 p.m. local time on April 21, 2020 and the commencement of the Board of Park Commissioners meeting on April 21, 2020 will not be read aloud but will be treated as regular correspondence. Abusive, profane, and/or personal attacks will not read aloud. Comments will be read in the order in which they were received during the time normally reserved for public comment. The period of public comment will be limited to thirty (30) minutes. Any comments unable to be read due to time limits will be treated as regular correspondence. Board members will generally not respond to the public comments or answer questions. A report of all comments received prior to 5:30 p.m. local time on April 21, 2020 will be collated, and the Board Secretary will include such comments in the official meeting minutes.
