#### PER MARQUEE (PORTABLE ONLY)

Woodridge Based: Non-Profit, Churches, Service/Civic Clubs **\$50**

(1) Maximum # of people/rental location:

- » Castaldo Park/maximum: 150
- » Echo Point Park/maximum: 100
- » 83<sup>rd</sup> Street Park/maximum: 100

(2) Security deposit and fees due at time of booking.

(3) Cancellation requests made in writing 31 days prior to a rental will result in a full refund of deposits, and fees, less a \$5 administrative fee. Cancellation requests made in writing between 8 and 30 days prior to a rental will result in a forfeiture of security deposit. Cancellation requests made in writing within 7 days of a rental or failure to show for permitted reservation will result in a forfeiture of the entire deposit and all rental fees excluding inclement weather days.

Refund requests due to inclement weather will be primarily based on the closing of Village Greens Golf Course on day of the rental, of which rental fees and security deposit will be refunded in full and/or due to other unforeseen circumstances per the reasonable discretion of the Executive Director or his/her duly authorized representative.

(4) Contact the District for field requests such as lining, dragging, etc.

(5) Light fee, plus cost of field rental.

(6A) Cancellation requests made in writing within 14 days of a rental or failure to show for the scheduled reservation may result in a forfeiture of the security deposit excluding inclement weather days.\*

\* Refund requests due to inclement weather will be solely based on the closing of Village Greens Golf Course on day of the rental and/or closing of any field by the District, of which rental fees and security deposit may be refunded in full.

(6B) Cancellation requests made in writing within 14 days of a rental and/or failure to show for schedule reservation may result in a forfeiture of the rental fee if the space is unable to be re-rented.

(7) Batting Cages free of charge to teams renting half or full field.

(8) Reservations and fees required 30 days in advance of rental date.

(9) Alcohol is not permitted.

(10) Minimum four hours required not to exceed six hours and limited to one rental per day.

(11) Security deposit due at time of booking.

(12) Cancellation requests made in writing 31 days prior to a rental will result in a full refund of security deposit and fees, less a \$5 administrative fee. Cancellation requests made in writing between 8 and 30 days prior to a rental will result in the forfeiture of the security deposit. Cancellation requests made in writing within 7 days of a rental or failure to show for permitted reservation will result in the forfeiture of the entire security deposit and all rental fees.
